VARIANCE AND APPEALS PROCESS BEFORE THE BOARD OF ZONING APPEALS

An applicant may request a variance from the Town of Orange Board of Zoning Appeals (BZA). To be granted, it must be determined that the variance request meets the exceptions outlined in State Code §15.2-2309(2). See also Town Code Chapter 19 Article 3 §3-60. The Board of Zoning Appeals cannot grant variances to allow uses not permitted otherwise, or to give special advantages to one property owner that other owners in the same situation do not enjoy. A form from The Town Office must be completed and a fee of ***\$200.00 plus \$175.00 advertising costs*** paid. The applicant is responsible for any and all required Public hearing advertisements and property owner notifications.

An applicant may appeal any decision or determination made by the Town of Orange Zoning Administrator to the Town of Orange Board of Zoning Appeals (BZA) within thirty (30) days of such decision or determination.

1. Applicant must submit a completed application form along with the ***\$200.00 review fee plus \$175.00 advertising costs***. The application form must accompany a plat of the property showing existing zoning and all adjacent property, with owners and uses. Applicant may schedule a pre-submission meeting with Zoning Administrator.
2. Staff reviews the application and an attachment for completeness, notifies the Board of Zoning Appeals of the submittal, and schedules the required Public Hearing. The meeting date will be scheduled far enough in advance to meet the State advertisement requirements (*The Town of Orange Board of Zoning Appeals meets on call*).
3. The applicant must attend the Public Hearing, make a presentation on the request, and be prepared to answer questions from the public, and the Board of Zoning Appeal members. Anyone else who wishes to speak on the request will be allowed to do so.
4. The applicant shall be responsible for all costs associated with the Public Hearing advertisements and joint property notifications.
5. The Board of Zoning Appeals will decide the Variance request based on the State guidelines. A decision is usually made the same night as the Public Hearing. However, the Board of Zoning Appeals may postpone a decision until a later meeting.
